Flu Vaccination Voucher

- You are only allowed to use one voucher code and must not try and re-use an already used code (unauthorised scans will by highlighted to your employer).
- We strongly recommend that you contact a participating pharmacy of your choice to establish whether an appointment is required at the pharmacy, to avoid disappointment.
- There is no cash alternative for any voucher. You can only use it for one flu vaccination and it must not be passed to another person it is strictly non-transferable.
- The supply of and any liability arising from the supply of your flu vaccination when you use your flu voucher is the
 sole responsibility of the relevant pharmacy and subject to the relevant pharmacy's terms and conditions,
 however they notify or make those available to you, for example on a form they ask you to sign or on their
 website.
- We may contact you from time to time to provide updates about flu vaccine availability at pharmacies. This will mainly apply if you have validated a voucher but not used it.
